In consideration for _____'s participation in the activities provided by Rhythmic Art including but not limited to all aspects of cheerleading, tumbling, trampoline, and dance training and/or competition, I am fully aware that any activity involving motion, height, or athletic activity creates the possibility of serious injury. _____

*I acknowledge that I am the parent or legal guardian of the child(ren) identified above and voluntarily authorize my children to participate in gymnastics activities at **RHYTHMIC ART**. I have read **RHYTHMIC ART**'s written warning of the dangers inherent in gymnastics and recognize that participating in gymnastics could involve risk of serious injury, which could be permanent. In consideration of my child(ren)'s registration in **RHYTHMIC ART**'s gymnastic activities, I and my child(ren) personally assume all risks whether foreseen or unforeseen, in connection with my child(ren)'s participation in this activity, and **WE AGREE TO DEFEND, INDEMNIFY, HOLD HARMLESS, WAIVE, AND RELEASE THE RHYTHMIC ART, TOGETHER WITH ITS OWNERS, OFFICERS, TRUSTEES, EMPLOYEES, AGENTS AND MEMBERS, AGAINST ALL LIABILITY, CLAIMS, AND CAUSES OF ACTION ARISING OUT OF, OR IN ANY WAY CONNECTED WITH MY CHILD(REN)'S PARTICIPATION IN THIS ACTIVITY.** _____*

*Further, I assume complete responsibility for any property damage and/or personal injury caused by my child(ren) in connection with his/her/their participation in gymnastics/wushu/dance/cheerleading activities at **RHYTHMIC ART**. I have fully and accurately completed the Medical Information section of my child(ren)'s enrollment application and assert that my child(ren) has/have no physical condition that would prevent or hinder his/her/their participation. In the event of any injury, I authorize **RHYTHMIC ART** and its employees to administer first aid, contact the local 911 system, transport my child(ren) to a hospital, initiate medical treatment and hold my child(ren) until I can be notified. I understand this Release Agreement is a contract and shall remain in effect for the duration of my child(ren)'s participation in **RHYTHMIC ART** gymnastics/wushu/dance/cheer. This agreement contains the Entire Agreement between the parties and supersedes any prior agreement whether written or oral. This Release Agreement shall bind my heirs, personal representatives, assignees, and all members of my family, including minors. _____*

Further, I recognize that at some time during the course of gymnastics/wushu/dance/cheer instruction, in order to achieve proper body placement and correct training exercises, the assigned instructor to my child may inadvertently touch his/her person in an impersonal manner while performing a "spot". A "spot" is the traditional way to correct body alignment and maintain safety in the sport of gymnastics/wushu/dance/cheer and is recognized as gym policy. _____

*Further, I have inspected the facilities at **RHYTHMIC ART** and its equipment and accept them as being safe and reasonably suited for the purposes intended. _____*
